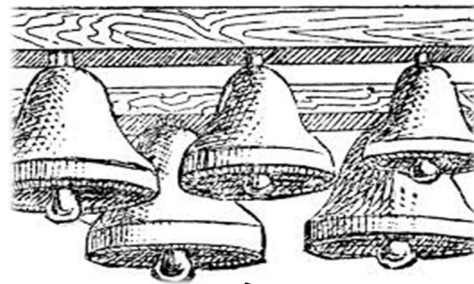

Letter from the Pastor

Dear Sisters and Brothers in Christ,

At our Vestry meeting, Wednesday, August 5, there was a serious discussion of the current status of the Novel Coronavirus Pandemic in Maryland and Nationally. Wednesday morning, the Diocese of Maryland announced to the clergy that it had ordered churches in Baltimore City and Baltimore County to suspend In-Church services due to the rising number of infections in those areas and throughout the state, and the decreasing number of available hospital beds. These circumstances make some of us feel as if it is most prudent to stay home at this time. And we know that there are those of us who wish to get back into our historic church.

The decision was to *remain cautious*, and **Sunday, September 13 has been designated as Homecoming Sunday 2020: this will be our first Sunday of In-Church worship with Holy Communion for those who feel it is safe to return.** We are allowed to seat between 17 and 26 people depending on how many pairs of people who live in the same domicile come. Those attending must wear a mask properly covering mouth and nose; must sanitize hands on the way in and the way out; there is no singing allowed. There will be a minimal amount of instrumental music, and communion will be distributed on the way out of church, not at the communion rail, so as to minimize the length of time we are in church as well as movement inside the church. (A more detailed description of Holy Communion follows in this issue.)

It was further decided to try a **Hybrid Schedule: 1st, 3rd and 5th Sundays will be a continuance of the current Live Stream Service with only the Celebrant in the church; 2nd and 4th Sundays each month will be In-Church Holy Communion as described.** This allows us to meet the needs of those who are comfortable returning to church and those who are not, as well as those who want to continue to “sing-together” from the comfort and safety of home.

It was further decided, given the number of people who wish to continue to worship from home, **All Services will continue to be Live Streamed every Sunday from now on.** Those who are uncomfortable for any reason, and especially anyone who does not feel well, are under no pressure to return until you and your personal physician make that decision.

As always, we will be subject to any changes in the intensity of the Pandemic and instructions from the Diocese of Maryland as we are still under Phase Orange restrictions. *We remain fully open to transition to a schedule of more Sundays per month of In-Church worship when it seems prudent to do so.* The current Hybrid Schedule is not written in stone and will be subject to constant review as we remain open to your feedback and suggestions from all members of Christ Church.

With the current *Live Stream Services on Sundays at 9:45am, and Monday through Friday at 11:55am, we are reaching as many as 45-60 households per service, with some people “attending”* Christ Church from as far away as Colorado, New Jersey and Athens, Greece, on a regular basis. Live Stream church services has expanded our reach to bring the Good News of Jesus Christ to more people every Sunday and six days a week. This is a remarkable development! I am thankful for all the people who have been working tirelessly to ready our church for a return to In-Church Worship, and those who have made it possible to Live Stream our services six days a week. As our bishops remind us, it is a New Day for the Church with new ways to bring the Good News to more and more people than ever before! Looking forward to seeing you all again soon.

We Are...

those People who are flexible in how we celebrate the Holy Eucharist

Throughout the Church's history, the ways in which God's people have celebrated The Lord's Supper, Holy Eucharist, Holy Communion, has taken and continues to employ different practices and take new shapes. For instance, based on stories in the Gospels, it is believed that some early Christians had Bread and Fish Eucharists! Some worshipped in groups in homes, some went to church. Some receive at a Communion Rail, some standing at a Communion Station, and to this day some churches seat people at a table in groups of Twelve to pass the bread and wine around the table to one another. There are even a few churches for which Holy Communion consists of washing one another's feet, as The Last Supper is described in the 13th Chapter of the Gospel according to John – which description includes no mention of bread and wine whatsoever!

Today, due to the ongoing Pandemic, new patterns of Holy Communion are being tried in churches throughout our diocese and throughout the Church worldwide! Here in the Diocese of Maryland, there are certain restrictions outlined in the Diocesan Guideline for Phase Orange: the Celebrant will both wash his or her hands and sanitize them; will wear a mask during the Prayer of Consecration; and will be the only person to receive the Bread and Wine, the Body and Blood; all others present will receive only the Bread – the Body of Christ. This is consistent with centuries-old Eucharistic Theology that says *communion in only one-kind is full communion*.

How the Body of Christ is distributed to those attending is a matter up to each local congregation. Having reviewed how different parishes in the Diocese are doing this, and per The Guidelines to keep the length of time that people are in church short, we have decided to distribute the Bread on the way out of Church. The Celebrant will stand near the entrance to the Church, wearing nitrile gloves and mask, and will drop the wafer into your outstretched hands. There will be markings on the floor of the church to help in maintaining a six-foot distance between parishioners on the way in and out of church.

We are all asked to sanitize our hands on the way in and the way out of church. No-Touch sanitizing stations have been installed at all entrances in all three of our buildings: the Church, Parish Hall and The Annex (offices). Everyone must wear a mask covering both mouth and nose throughout the entire service. Extra masks will be available for those who may forget to bring one. Singing will not be allowed, but we are allowed "to hum" along with any instrumental music that may be playing with the mask still on.

To meet the guidelines, the number of lessons will be reduced, the sermon shortened, and there will be only one or two verses of hymns played, with a minimal number of musical selections each week. *Passing the Peace will be exactly that – a bow or a wave while standing in place, no handshakes or hugs allowed.*

This will all take some getting used to, and as with everything else, will be subject to change – circumstances alter cases! But then, those who endeavor to faithfully follow Jesus have always been open to change from the very beginning. Saint Benedict in his Rule of Life reminds us that those who follow Christ are those who are open to Always Begin Again! Each day calls us to new ways of being God's People, if in fact that is truly who we want to be. As Joshua announced to the Twelve Tribes of Israel, "As for me and my household, we will serve the Lord." We are those people who do not follow our own desires, but rather in our baptism we promise to follow obey Christ as Lord. This is why we read and re-read the four Gospels and all of the Bible – to see where he goes, who he spends his time with, what he says, what he does and thereby come to know who we are and whose we are, and what we are called to Be and to do.

We are those people who Take, Break, Bless and Give Away all that we are and all that we have as Jesus does in the Feeding of the Five Thousand in that archetypal Bread and Fish Eucharist!

CELEBRATE THE 100TH ANNIVERSARY OF THE RATIFICATION OF THE 19TH AMENDMENT!

Molly Neal, our senior warden, was head of the Harford County Election Board for several years. We, the Christ Church ECW would like to recognize and preserve the contributions of all the women who came before us and fought for our freedom to vote and for being a part of the political decision making of our country. Think of these ladies on August 26th. Thank you ladies and get out to vote this Fall!!

Christ Church Vestry Minutes

June 24, 2020

[Virtual meeting via Zoom]

Attendance: Fr. Kirk, Lyn Edmunds, Lois Tidey, Molly Neal, Leigh Spicer, Laurie Morris, Lynn Klein and Kate Davis.

The meeting began at 7:05 PM with contemplative silence.

The vestry minutes from our last meeting on June 10th were approved.

Rector's report – Fr. Kirk presented the vestry with a proposal from B&H Photo – Video for all the equipment needed to live stream services (proper video camera, 2 microphones, laptop, etc.), which will continue even after we re-open. We still have more than enough reserved from the communications grant that we received from the diocese last year to cover the cost (about \$1800). We voted to approve this purchase.

Senior warden's report – Molly has been visiting some members who don't have internet access; they are doing well. Kate and Justin recently cleaned the choir area, Narthex and underneath pews in the church, as part of a service project for Justin's Boy Scout troop. Mary Jane and Dave Martell have been doing some cleaning in the Parish Hall, Annex and church grounds.

The ECW will be moving forward with the purchase of a sanitization system (includes 4 wall-mounted and 2 free-standing sanitizers) and it should arrive by mid-July. The vestry agreed this would be a good idea, as we would need to have plenty of sanitization options readily accessible before we re-open. People continue to learn something new from the Noon-day prayers that Fr. Kirk leads each weekday. He also is getting a lot out of the practice.

Over the past week, vestry members helped conduct a phone survey of our regular parishioners about when/how to regather for live service. Lyn Edmunds helped create the survey and compiled the results, and Molly helped with an informative letter outlining the requirements for re-opening (including a copy of the Covenant for Re-gathering) that was sent via email to the parish beforehand. A total of 49 (out of a possible 56) members of Christ Church were surveyed. We were very pleased by the participation level and appreciated everyone's input.

Highlights from the survey are as follows:

Fully agree to the "Diocese Covenant for Re-gathering" = 40 (others agree, but admit restrictions will limit participation or delay return)

When to return?

Now = 17

By July 19th = 7

By Sept. 20th = 11

Beyond Sept. 27th = 11 (eg., until vaccine, no masks, better treatment, numbers decrease)

Communion?

No Communion = 24

Wafer from Fr. Kirk = 18

Wafer from cup or tray = 16

(some endorsed more than one)

Currently attend live-streamed service = 38 regularly; 3 sometimes.

Our average attendance at Sunday service, prior to the pandemic was 25. Fr. Kirk will be ready to return to service inside when the majority of parishioners are ready, and once we have all the protocols in place. Status of preparations:

- Cleaning team is available to help with thorough cleaning after Sunday service
- Supply of disposable masks (for anyone who needs one) has arrived
- Sanitizer stations/supplies are being ordered and should arrive by mid-July
- Still need to get signage up (generic signs are available from the diocese)
- Would need to have a sign-in sheet for attendees
- Would need a greeter/usher

We need a volunteer to help spearhead the coordination of a greeter/usher as a Rota position. We discussed the goal of re-opening the church with the new protocols in place by August 2nd, but we'll need to re-visit at our next meeting.

There are 4 AA groups that use our Parish Hall. We would need to make sure that a representative from each group is trained on the procedures and has their own cleaning supplies (it will be very important that each group disinfects anything they touch). The hall can accommodate about 30 people with physical distancing in place.

We will meet again in 2 weeks.

The meeting ended with the Lord's Prayer, at 8:50PM.

Christ Church Vestry Minutes
July 8, 2020
[Virtual meeting via Zoom]

Attendance: Fr. Kirk, Lyn Edmunds, Lois Tidey, Molly Neal, Leigh Spicer, Laurie Morris, Leslie Amtmann, Marianne Kidd, Lynn Klein and Kate Davis.

The meeting began at 7:05 PM with contemplative silence.

The vestry minutes from our last meeting on June 24th were approved.

Treasurer's report – the balance in checking account is currently \$6,192, of which \$5, 529 is reserved. We have received contributions toward cleaning/sanitization supplies, which will be put to good use for when we re-open. The treasurer's report was approved.

Cemetery report – this Saturday, there will be two interments. There will be a small/private funeral ceremony in the church.

Rector's report – our regathering plan was approved by the diocese. Fr. Kirk relayed information gathered from the recent conversation amongst clergy, the bishop and Scott Slater. Something to consider when we re-open would be whether we'd want to have the windows open for better ventilation. It was discussed that it would probably be too hot/humid, even with the windows open. Another idea would be to have communion given on the way out of church, during the initial phase of re-opening, to minimize the amount of moving around during service. We could also place

bulletins at the marked seats, rather than handing them out.

The air conditioning in the church recently went out, due to outage from a storm. Michael & Sons will be coming to detect the problem and hopefully it is only the compressor that needs fixing.

Prior to holding inside meetings/classes, each group that uses our Parish Hall will need to have a concrete/written re-opening plan.

We're still aiming for August 2nd as the first date to re-open inside church services. We discussed a plan to do a test run of logistics with a few members of the vestry, while Fr. Kirk conducts the service on July 26th.

We will meet again on July 29th at 7pm.

The meeting ended with the Lord's Prayer, at 8:35PM.

Kate Ryan Davis was born in Tarrytown, New York, which is a suburb of Manhattan. She has one younger sister who now resides in Florida. There is a large extended family on her Dad's side since he was one of eight children. With 26 first cousins they have a family reunion in upstate New York every summer. But this is the first time in over 30 years that it had to be cancelled, due to the pandemic. They were especially concerned about the safety of the elderly aunts and uncles.

Kate's early education was in Tarrytown and she attended Sleepy Hollow High School with an actual mascot being the headless horsemen! Her middle school was Washington Irving. She received a Bachelor's in mathematics from Bard College. Who would have guessed she can speak French, after studying the language for nine years! They were married at an Episcopal church in Kennett Square, PA called Church of the Advent. The priest who married them was named Dave Thomas (and they said he actually looked and sounded like the spokesman from the old Wendy's commercials). Tony's job brought them to Maryland and they have made it their home ever since. They have two sons, Tyler (15) and Justin (13), who were both baptized at Christ Church Rock Spring parish and of course, we all know them from being acolytes and helpers at our events! Early in Kates' career she was a Benefits Analyst at Mercer HR Consulting (in Stamford, CT and then in Philadelphia, PA for 8 years). Once they started a family, Kate was able to stay home for 8 years as a full-time caretaker. She says she is so glad to have had the opportunity to be home with the boys during their early years. Even though it was both challenging and exhausting at times she would do it all over again. She says that is when she really learned to juggle many different things at once!

For the past 7 years she has been back to work in the HR field, most recently as the HR Manager for a company as it continues to grow in Forest Hill. She feels very needed at work and feels her services are really helping the company as it continues to grow. Her days go by very fast, as there are plenty of routine tasks (like payroll, recruiting/onboarding, benefits administration and employee relations). She has noticed one thing during this time of having to work from home during the pandemic and that is that there is less "drama" to worry about. They continue to have meetings virtually and everyone has been very productive. When she has extra time Kate hikes, takes yoga, reads and visits National Parks. She used to take ballet until a foot injury (another surprise talent I learned she had). She just finished an interesting book called "The Alchemist" by Paulo Coelho. The Davis family also includes their dog – a Cavalier/Bichon mix – named Buster. Buster is about to turn 9. Kate says that Buster is the best listener in the family and also is everyone's buddy!

We would like to thank Kate and her family for all their support to Christ Church. Kate is not only registrar of the vestry, she is also an Altar Guild member who organizes a lot of the flower set ups like at Christmas and Easter, helps the ECW in many of their endeavors, both of the boys have been acolytes and Tony is in the Men's Group (you probably have seen him cooking at the spaghetti dinner). 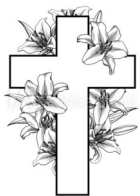

Covenant for Regathering

In response to the current COVID-19 pandemic, I promise, with God's help and to the best of my ability, to abide by the guidelines of the Diocese of Maryland for participation in the life of my congregation according to the regathering phase in which my congregation is authorized to carry out its mission and ministry.

In fulfillment of the Baptismal Covenant (*BCP* p. 304-305), I will strive to:

Love my neighbor as myself, I will...

- Wear a mask or scarf over my nose and mouth at all times in church buildings, except momentarily to receive the sacrament or lead worship through an assigned speaking part, and follow public health guidelines for hand sanitizing and disinfecting
- Only attend worship and receive communion if I am non-symptomatic for the COVID-19 virus or any other transmittable disease that could compromise the health of another congregant
- Will abstain from attending if doing so would put me at greater risk due to my own health status

Respect the dignity of every human being, I will...

- Make no physical contact with people beyond the members of my own household
- Maintain a six foot or more distance from other members of the congregation
- Respect any requests for distance, masking, and cleaning, to ensure the safety and comfort level of others

Seek and serve Christ in all people...

- Trust and support the decisions of both my diocesan and congregational leaders
- Stay connected with others in my community by telephone, video chat, or mail
